

KANSAS BOARD OF EXAMINERS IN OPTOMETRY
Minutes of the 4 September 2019 Meeting

- I. 7:11 pm called to order by Ron Hansen, OD, President. Members of the Board present were Drs. Gerard Lozada and Craig Newland. Also, in attendance were Randy Forbes, Board Counsel, Jan Murray, Executive Officer, and Todd Fleischer, KOA representative. Dr Rebecca Sparks and public member Gary Slimmer joined later. Members of the public present were Josh Nosal, representing Acuity, Justin Weigel, OD and Chad Cook.

- II. Trade Names:
 - A. Dr Newland motioned and Dr Lozada seconded a motion to approve the trade name of *Hopkins, Ackerman, & Drees, Optometrists, LLC*, 802 Campus Drive and 712 St John, Garden City, KS for George A Hopkins, OD, Scott M Ackerman, OD and Adam J Drees, OD. Motion passed 3-0.
 - B. Dr Lozada motioned and Dr Newland seconded a motion to reject the trade name of *KC Vision Center* for Evan Strong, OD and Jayme Fose, OD citing the use of *KC* is too broad of a geographical area and would be misleading. Motion carried 4-0.
 - C. Dr Lozada motioned and Dr Hansen seconded a motion to reject the trade names of *Wichita Vision & Myopia Management Center, Wichita Vision & Myopia Control Center* and *Wichita Vision & Myopia Clinic* citing the use of *Wichita* is too broad of a geographical area and would be misleading. Motion carried 4-0.
 - D. Dr Newland motioned and Dr Hansen seconded a motion to approve the trade name of *Acuity Vision Center, LLC* for Neal Troyer, OD and Justin Weigel OD. Dr Newland then rescinded this motion and amended to: Approve the trade name of *Acuity Vision Center, LLC* and approve the transfer of *Insight Vision Center* to *Acuity Vision Center, LLC* for Neal Troyer, OD and Justin Weigel, OD. Motions for amendment to the original motion and the amended motion each carried 4-0.
 - E. Dr Hansen motioned and Dr Lozada seconded a motion directing Mr Forbes to write a letter to Tim Moore, attorney for Bruce Boyle, OD, citing that his motion for Summary Disposition and Request for Order Permitting Limited Use is not a board issue. Motion carried 5-0.
 - F. Dr Sparks motioned and Dr Lozada seconded a motion authorizing the extension of the previously-approved trade name of *Visionaries Eyecare* for Steven Miller, OD, until March 31, 2020. Motion carried 5-0.

- III. Dr Newland motioned and Dr Hansen seconded a motion to adjourn. Motion carried 5-0. The Board adjourned at 7:55 pm.
