SUMMARY ORDER
NOW ON THIS 23 ^{rcl} day of <u>July</u> , 2020, this matter comes
before Tucker Poling, Acting Executive Director, Kansas State Board of Healing Arts ("Board"),
in summary proceedings pursuant to K.S.A 77-537. Pursuant to K.S.A 77-537, this Summary
Order shall become effective as a Final Order, without further notice, if no written request for a
hearing is made within fifteen (15) days of service.
Upon review of the agency record and being duly advised in the premises, the following
findings of fact, conclusions of law, and order are made for and on behalf of the Board:
Findings of Fact
1. Jand Inc./Warby Parker ("Registrant") is an entity based in New York, New York which
dispenses contact lenses in Kansas. Registrant was originally issued registration number 75-00026
to distribute contact lenses in the state of Kansas on or about June 26, 2018. Registrant's current
registration designation is Active. Registrant most recently renewed such registration on or about
May 7, 2020.
2. The last known mailing address for Registrant is: 233 Spring St 6th Floor E, New York,
NY 10013.
3. On or about June 27, 2019, Registrant failed to meet the deadline for registration with the
Board for their 2019 renewal.

- 4. On or around September 17, 2019, the Board received an Application for Registration to Dispense Contact Lenses by Mail and \$150 registration renewal fee check from Registrant.
- 5. On or around October 4, 2019, the Board approved the Application for Registration.
- 6. Due to the discovery of Registrant's continued dispensing of contact lenses to Kansas residents without proper registration,

 CONFIDENTIAL was initiated.
- 7. On or around October 10, 2019, a Board Investigator submitted a request for written response requesting a comprehensive list of all Kansas resident patients for whom Registrant distributed contacts to between June 27, 2019, and October 3, 2019.
- 8. On or around November 22, 2019, Jill Savage, Managing Counsel for Registrant, provided a written response to the Board Investigator's request stating that between June 27, 2019, and October 3, 2019, Registrant distributed contacts to approximately twenty-three (23) Kansas residents. During this time period, Registrant did not have an Active registration to distribute contact lenses to residents in Kansas.

Applicable Law

- K.S.A. 65-4967(a) of the Patient's Contact Lens Prescription Release Act defines an entity dispensing contact lenses as:
 - ...a person or entity not licensed under K.S.A. 65-1505, and amendments thereto, or licensed to practice medicine and surgery in Kansas who mails or delivers, using commercial courier or overnight or other delivery services, contact lenses to patients in Kansas pursuant to a contact lens prescription which such person or entity did not determine.
- 10. K.S.A. 65-4967(b) of the Patient's Contact Lens Prescription Release Act further states:

No person dispensing contact lenses as defined under subsection (a) may dispense contact lenses to Kansas residents unless such person meets the requirements of this section, is registered under this section and pays the annual registration fee set by the state board of

healing arts.

11. K.S.A. 65-4968(b)(1) states:

Upon a finding of any violation of the patient's contact lens prescription release act, in lieu of or in addition to any other action, ... the state board of healing arts for persons subject to the provisions of K.S.A. 65-4967, and amendments thereto, registered under K.S.A. 65-4967, and amendments thereto, or licensed by the state board of healing arts to practice medicine and surgery may assess a civil fine not in excess of \$10,000 against such person dispensing contact lenses under this act.

Conclusions of Law

- 12. The Board has jurisdiction over Registrant as well as the subject matter of this proceeding, and such proceeding is held in the public interest.
- 13. The Board finds Registrant is subject to the provisions of K.S.A. 65-4967(a) in that it is an entity dispensing contact lenses.
- 14. The Board finds Registrant violated K.S.A. 65-4967(b) in that Registrant dispensed contact lenses to Kansas residents without meeting the requirements of the section, because Registrant had continued to ship contact lenses to approximately twenty-three (23) Kansas residents between June 27, 2019, and October 3, 2019, the time period in which Registrant's registration had lapsed.
- 15. Based on the facts and circumstances set forth herein, it appears that the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a), in that the use of summary proceedings does not violate any provision of law and the protection of the public interest does not require the Board to give notice and opportunity to participate to persons or entities other than Registrant, Jand Inc./Warby Parker.

IT IS, THEREFORE, ORDERED that Registrant is assessed a CIVIL FINE in the amount of seven thousand five-hundred dollars (\$7,500) for Registrant's violations of the

Patient's Contact Lens Prescription Release Act. Such fine shall be paid to the "Kansas State Board of Healing Arts", in full, on or before **September 1, 2020**. All monetary payments, which shall be in the form of check or money order, relating to this Summary Order shall be mailed to the Board certified and addressed to:
